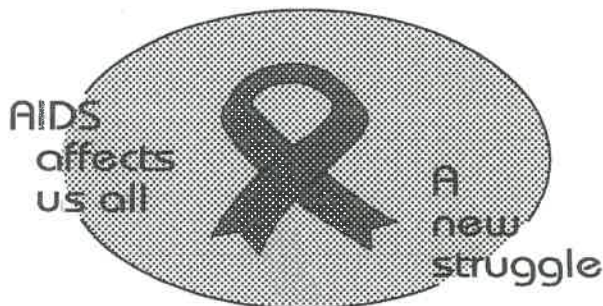

VUSUMUZI Vilakazi has landed a top position at Chippa United following his exit from Golden Arrows on Sunday.

"Having Mr Vilakazi, with his calibre and experience, join our club is indeed a proud moment for us. I am eagerly anticipating his contribution to our development structures, and confident that his insights will immensely benefit our first team," Mpengesi said.

"As Chippa United Football Club, we are optimistic that with Mr Vilakazi's leadership, the club is poised to usher in an era of footballing brilliance, building upon its robust legacy which is to be the Pride of the Eastern Cape."

Vilakazi arrives at Chippa after the club had to withstand a tough opening period of the season, where they faced Kaizer Chiefs, Orlando Pirates and Mamelodi Sundowns in their opening six league fixtures.

Under the guidance of coach Morgan Mammila, who once held the same position as Vilakazi, the club managed six points in that same period – having lost two, won one and drawn three matches before the international break.

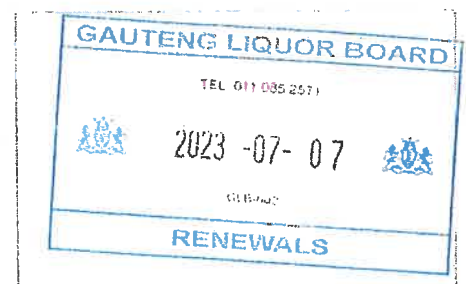
