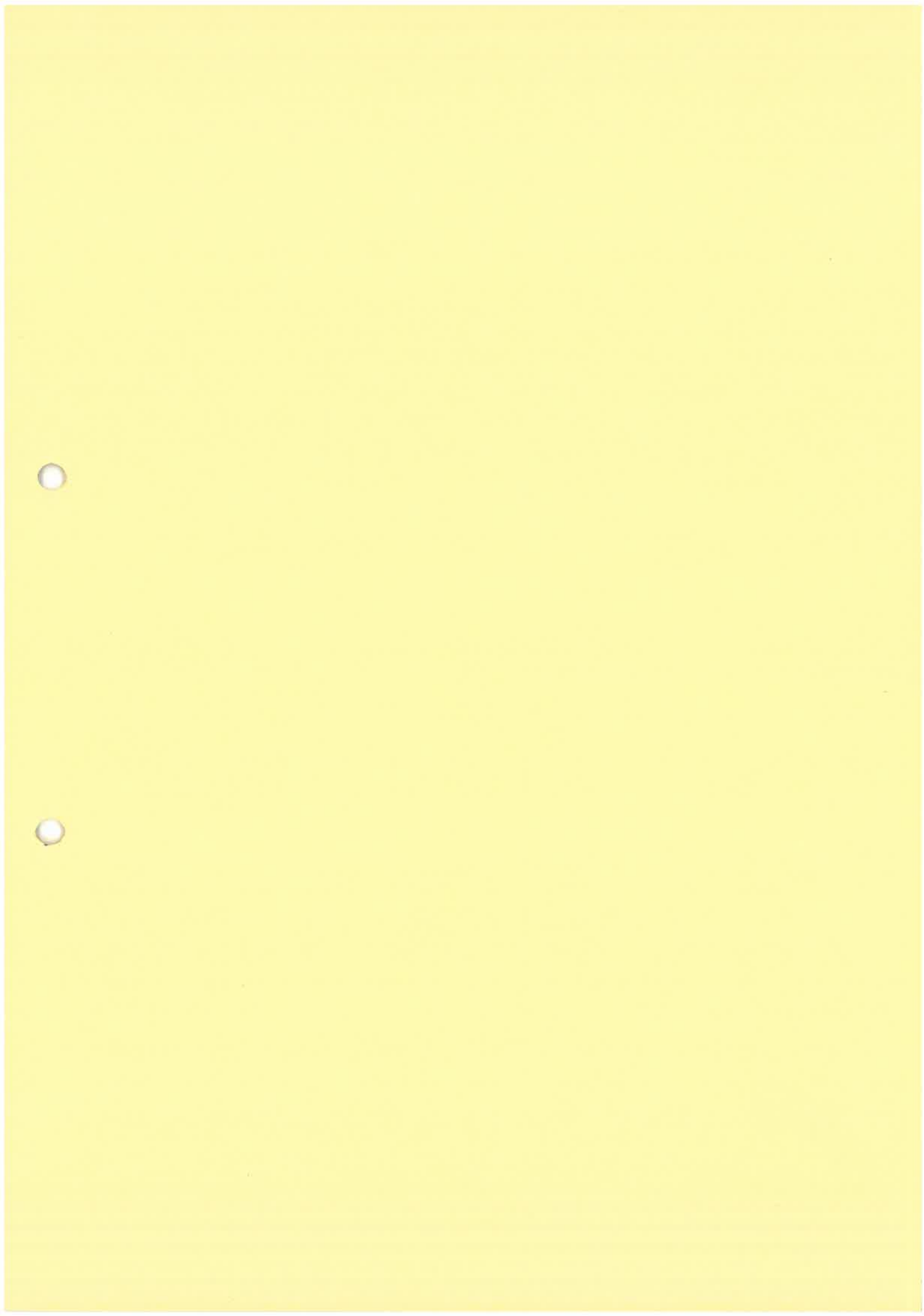

**SUBJECT: ENQUIRY WITH REGARD TO 10 LIMITED PAYOUT GAMBLING MACHINES ON ERF 541 SPRINGS TOWNSHIP.**

The above mentioned matter has reference.

We refer to the undated facsimile which we received on 08 July 2009 in which you enquire about the land use rights on the above mentioned property with the specific reference to zoning that caters for Ten (10) limited payout gambling machines.

The zoning of the property is "Business 1" in terms of the Springs Town Planning Scheme of 1996 and does not prohibit limited payouts gambling machines to be operated on the site. However a licence from National Gambling Board is still required.

The Springs Town Planning is silent about the number of machines that will be permitted. However the number of machines should be limited to such extent that the associated activities do not have a detrimental effect on the surrounding area.

We trust you will find the above to be in order.
