### CALL FOR PROPOSALS FOR GRANT FUNDING

The Gauteng Gambling Board (GGB) is a Schedule 3C Public Entity in terms of the Public Finance Management Act, 1999 (Act 1 of 1999). The GGB has been established in terms of section 3 of the Gauteng Gambling Act, 1995 as amended ("the Act")

#### Objective:

The objective of this advertisement is to invite Non-Profit Organisations (NPOs), Non-Governmental Organisations (NGOs), and Non-Profit Companies (NPC), to submit their proposals for the following:

1. Grant funding through the Sports Development Fund (SDF) and Corporate Social Investment (CSI);
2. to administer the bursary scheme on behalf of the Gauteng Gambling Board (GGB) in support of tertiary education initiatives intended to alleviate the socio-economic challenges faced by the Gauteng community.

#### Bursary Administration

Preference will be given to the organization(s) with a focus on the following areas:

- a. Organisation(s) with internships pipelines;
- b. Spread over all 5 regions in Gauteng
- c. Targets previously disadvantaged groupings
- d. Experience in training and skills development targeting youth.
- e. Ability and/or experience in creating employment opportunities or job placements for bursary recipients prior to or upon graduation.

#### SDF& CSI Funding

- Sports programs in support of old age groupings in Gauteng
- Sports programs in support of sports legends in Gauteng (E.g Soccer, Rugby, Athletics etc)
- Sports programs in support of youth in Gauteng
- Sports programs in support of people with disabilities in Gauteng

- Sports program in support of aquatic sports and maintenance of aquatic facilities

#### Adjudication:

In adjudicating applications, the GGB will give preference to applications from Non-Profit Organisations (NPOs), Non-Government Organisations (NGOs), and Non-Profit Companies (NPC) that have a focus in underdeveloped areas. These organisations:

1. **Bursary administration;** must have experience in administering bursary schemes, and disbursement of bursary funds and have at least three references.

2. **CSI & SDF application;** must focus on underdeveloped areas, advance the interests and participation of women, youth, and people with disabilities, as well as projects that lead to job creation and retention
